Registration Financial Policy

1. Purpose

This Financial Policy outlines the expectations and obligations for families regarding registration fees, payment plans, refunds, and other financial matters related to participation in the BVBIA Georgia Peachtree City, BVBIA Georgia West or BVBIA Georgia Dublin (the “Club”). By registering a player, parents/guardians agree to the terms and conditions outlined in this policy.

Fee Commitment

Players who accept an invitation to play with the Club commit to paying the full registration fee, regardless of attendance or continued participation. The registration deposit is non-refundable. In the absence of a deposit, the following is true: Academy Programs \$200 is non refundable. Recreational Programs, \$25 is non refundable. By accepting a roster spot, families agree to fulfill their full financial obligation.

Refund Policy

- The initial registration deposit is non-refundable under any circumstances.
- No refunds will be issued for voluntary withdrawal or failure to participate after registration is completed.
- Refunds or prorated fees will only be considered in the following cases:
 - The family relocates more than 50 miles from the Club’s location.
 - The player sustains a season-ending injury (must be verified by a licensed medical professional).
- All refund requests must be submitted in writing and will be reviewed by the Club’s Board of Directors. admin@bvb-ia-georgia.com

Payment Plans

To support families, the Club offers structured payment plans. All plans must be arranged at the time of registration. Failure to make timely payments may result in late fees or suspension of the player’s eligibility to participate in training or matches.

Each installment payment will incur an additional \$20 administrative fee (known as “admin fee”). Installments not received within five (5) days of the due date will incur a \$25 late fee.

Club Payment Plan Options

Families may choose from one of the following payment options upon registration. The \$300 non-refundable deposit is due immediately to secure a player’s spot. Installment plans begin on July 1 and are paid monthly.

Each installment includes a \$25 administrative fee. Installments not received within five (5) days of the due date will incur a \$25 late fee. All plans must be paid in full by the final due date.

Delinquent Accounts

Accounts that are 15 days past due may incur a late fee. If an account becomes more than 30 days delinquent, the Club reserves the right to suspend the player’s participation until the account is brought current. Communication is encouraged if families encounter financial hardship.

Financial Assistance

Limited financial assistance may be available to eligible families. Applications must be submitted with supporting documentation and will be reviewed on a case-by-case basis. Assistance decisions are subject to available funding and Club policies.

Agreement

By registering, families acknowledge that I have read, understood, and agree to abide by the Club Financial Policy. I understand my financial obligations and the conditions under which refunds or payment adjustments may be considered.
